

REVIEW OF ANNUAL REPORT AND AUDITED ACCOUNTS OF BRAITHWAITE & COMPANY LIMITED FOR THE FINANCIAL YEAR 2014-15

Background:

Braithwaite & Co. Limited (BCL) was incorporated in 1930 as a private sector organization. Government of India nationalized it in 1976 and it became a Public Sector Enterprise. The Company was under the Administrative Control of Ministry of Heavy Industries and became a wholly owned subsidiary of Bharat Bhari Udyog Nigam Limited w.e.f. 30.05.1987. At present, BCL is under the administrative control of Ministry of Railways w.e.f. 06.08.2010.

Manufacturing of wagons to the requirements of Indian Railways, structural fabrication jobs and manufacturing, retrofitting of EOT crane are the main activities of the Company. Presently, BCL is also manufacturing wagons for clients other than Railways, structural fabrication (bridge girder) at site and refurbishment of wagons.

Performance Highlights:

The year has seen severe downfall as compared to the past few years, where the production of Wagons was only 738 Nos. resulting in unutilized capacity. The execution of Structural fabrication was NIL. The turnover in the service sector was negligible on account of closure of KoPT AMC contract. However during the year, the company manufactured 1514 Nos Bogies and managed to surpass the record Bogie production of 1500 Nos. during 2013-14.

- 6. The Company has been awarded "Special Award For Turnaround Category 2015" by Bureaucracy Today.
