Reference to above revised tender Para No. (E -2) (Page No. 9 of 31), the Submission/Maintenance of Security Deposit shall be as under:

On receipt of the PO, the successful bidder shall submit Security Deposit(SD) equivalent to 5% of the Contract Value of First Year quantity i.e. 1800 Bogies, in the form of DD/BG. BG shall remain valid for the entire contract period including warranty.

However, for the second and third year, an additional amount equivalent to 5% of the Contract Value for 200 Bogies in each year shall be deposited before the end of previous year.

Effectively, in the Third Year, the SD amount to be maintained shall be equivalent to 5% of the Total Contract Value of 2200 Bogies.

Further, reference to above tender Para No. (E -11) (Page No. 12 of 31),

Existing Clause	Revised Clause
Delivery: Monthly delivery should not be less than 130 Nos. Bogies	Delivery: Monthly delivery should not be less than 150 Nos. Bogies. However, in case of shortfall from the monthly target, penalty shall be imposed as per LD clause. Delay period shall be calculated from the end of each month to the date of DM of shortfall bogies of the previous month.

Bidders should submit a declaration along with Techno- commercial Bid stating that there is no proposal , under consideration by them with regard to change of their name / organizational status nor their name / organizational status has been changed as on date of opening of the tender. In case there is a change in the name / organizational status, the same will be intimated to BCL promptly along with relevant documents not later than 15 days from the date of such change failing which the bidder shall be prepared to accept the penalty, as will be decided by BCL including forfeiture of EMD / equivalent amount.

Techno-commercial Bid of the above tender shall be opened on **06.07.2018 at 3.00 pm**
