Following changes will be applicable to the above Tender enquiry.

**QUALIFYING CRITERIA** of Page – 2 shall be read as follows in place of existing stipulations:

**(A) QUALIFYING CRITERIA**

**(i) Financial Eligibility:**

- ◆ Bidder should have average minimum Annual Turnover of **Rs. 17.06 Cr** during last 3 (Three) years ending on 31.03.2017. Bidder must have earned net profit in any one of the last 3 (Three) financial years ending on 31.03.2017 and should have positive net worth as on 31.03.2017.

Audited Balance Sheet and Profit & Loss Accounts for last 3 (Three) years ending on 31.03.2017 need to be submitted in support of above requirement.

- ◆ **Solvency Certificate from Banker for Rs. 10 Crore is to be submitted.**

**(ii) Technical Eligibility:**

- ◆ Experience of having successfully executed similar works (defined below) during last seven years ending **31.07.2018** fulfilling any of the following criteria:

Three similar executed works each costing not less than **Rs. 22.75 Cr.** OR executed three similar works of Fabrication involving not less than **2651MT** of Fabrication against each such job.

**OR**

Two similar executed works each costing not less than **Rs. 28.44 Cr.** OR executed two similar works of Fabrication involving not less than **3314 MT** of Fabrication against each such job.

**OR**

One similar executed work costing not less than **Rs. 45.50 Cr.** OR executed one similar work of Fabrication involving not less than **5302 MT** of Fabrication against such job.

**The term "Similar Works" means works of following nature:**

Experience of Fabrication of Rolling Stocks of Indian Railways.

Besides, following additional conditions are applicable:

- ◆ The bidder should submit supporting document with respect to the jobs carried out as a proof of experience duly inspected by renowned inspection agencies like RDSO, RITES, Zonal Railways, & approved inspection agency of TPOA (third party quality assurance).
- ◆ The job may be carried out either in registered wagon builders' premises or any other premises duly inspected by RDSO / RITES / Railways' own inspection, The bidder shall submit relevant documents in support of such experience.
